The camp is meant to empower adolescent girls with life skills and prepare them for the future challenges of society. The theme of 2019 ANDM Girls Camp is, "Knowing your Worth, (Mind, Body and Spirit)". The narrative is simply that adolescent girls are getting into a stage where they are exposed in a plethora of challenges. These include body changes and development which could lead to unplanned teenage pregnancy if they are not well informed.

They are under immense peer pressure and they find themselves having to abuse substances like alcohol or worse. At times they even start smoking and some have been sexually abused. Alfred Nzo District Municipality prides itself as a youthful district and prioritizes the young people especially girls as future leaders and people with prospect of making change in the region and improve economic status and the orientation of the region.

1.1 INTRODUCTION

SPU planned to do Alfred Nzo District Municipality Girls Camp for the girls between 14 – 17 years of age in the second quarter of 2019 / 2020 financial year. The programme seeks to gather adolescent girls and create an opportune moment for adolescent girls to be inducted on life skills. The camp is assembled to create an opportune moment for the girls to realize their worth, understand their bodies and develop their spirit of contributing to transformation of Alfred Nzo Region. The camp will be held during the school holiday of September on the 25 – 29 September 2019.


