If you don't pay rates you must submit both affidavit and Proof of residence from Ward Councillor, If you submit one of the two you will be disqualified.
- Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit, **Failure to submit will result in zero points score for BBBEE status level**
- Joint Venture BBBEE must be combined
- **Copies of ID Documents and all submitted certificates must be certified**
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1.
- Company profile with traceable references
- The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Bids received after the published closing date will not be considered and will not be opened
- Bidders are required to submit Proposed Project Team, their CV's and qualifications.
- **All bidders should complete MBD 1, MBD 4, MBD 8, MBD 9 and Ethics Commitment For Suppliers Of Alfred Nzo District Municipality**
- All prospective service providers of goods and services and infrastructure procurement are to be registered on Central Database in order to business with all organs of state in the Republic of South Africa.
