If you don't pay rates you must submit both affidavit and Proof of residence from the councilor, If you submit one of the two you will be disqualified.
- Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a
 Registered Auditor or a Sworn Affidavit- Failure to submit will result in zero points score for
 BBBEE status level.
- Copies of ID Documents and all submitted certificates must be certified
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Bids received after the published closing date will not be considered and will not be opened.
