- Certified copies of BBBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit- **Failure to submit will result in zero points score for BBBEE status level.**
- **Copies of ID Documents, CK and all submitted certificates and CK must be certified**
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Quotation received after the published closing date will not be considered and will not be opened.
- **All bidders should complete MBD 1, MBD 4, MBD 8, MBD 9 and Ethics Commitment For Suppliers Of Alfred Nzo District Municipality**
- All prospective service providers of goods and services and infrastructure procurement are to be registered on Central Database in order to business with all organs of state in the Republic of South Africa.
