- Certified copies of BBEE certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit- **Failure to submit will result in zero points score for BBEE status level.**
- **Copies of ID Documents, CK and all submitted certificates and CK must be certified**
- The bid will be evaluated according to the preferential procurement model in the Preferential Procurement the bidders' attention is drawn to Form MBD6.1. The Alfred Nzo District Municipality is not bound to accept the lowest or any bidder.
- Quotation received after the published closing date will not be considered and will not be opened.

**Failure to supply all required and supplementary information will result in the tender being deemed non-responsive; and therefore the tender will not be considered for award.**


#### **BID CLOSING DATE**
