If you don't pay rates you must submit both **affidavit stating that you do not pay rates and Proof of residence from Ward Councillor**, If you didn't submit one of the two you will be disqualified.
- **Please Note that Bidders who are in arrears for ANDM services for a period of more than 3 months will be disqualified.**
- **A Signed lease agreement will be accepted for Bidders that do not own property and not liable for rates.**
- Certified copies of BBEE, certificate issued by a Verification Agency accredited by SANAS or a Registered Auditor or a Sworn Affidavit, **Failure to submit will result in zero points score for BBEE status level**
- **Copies of ID Documents and all submitted certificates must be original certified**


