1. BACKGROUND AND OVERVIEW OF THE PROJECT

1.1 INTRODUCTION

The ANDM Water Treatment Works sites are not all cabled. Employees that are based on those sites that are not cabled are not able to use their computers to connect to the ANDM network. It makes difficult for them to communicate with the rest of ANDM employees, not getting emails etc.

Because of the reason mentioned above, the ICT Section has developed a program of cabling all those ANDM Water Treatment Works sites and also to link them to our network infrastructure so that users on these satellite will get the same services that users on main office are getting.

1.2 OVERALL AND SPECIFIC OBJECTIVES OF THE PROJECT

1.2.1 Overall objective

The aim of the project is to link Matatiele Water Treatment Work to our existing network infrastructure to Matatiele WSP Office.

1.2.2 Specific Objectives

Because of the reason mentioned in introduction, the ICT Section has developed a program of cabling all those ANDM Water Treatment Works sites and also to link them to our network infrastructure so that users on this satellite will get the same services that users on main office are getting.

2. SCOPE & EXTENT OF WORK

- Bids are invited from suitably qualified professional service providers to prepare and submit proposals to undertake the required to connect and configure these two (2) Radio Access Points i.e. one Radio Access Point from Matatiele Water Treatment Work that will connect to the other Radio Access Point that will be at Matatiele WSP office.
- The Service Provider is required to connect a cable from the switch to the Access Point to enable it to connect.

It will be the responsibility of the Service Provider (SP) to ensure that these sites
can see one another as they supposed to, using the correct tools.
