- Valid SARS pin number confirmation certificate - Non-submission will lead to disqualification
- Municipal clearance certificate certifying that no municipal rates and service charges are owed by the bidder and any of its directors to Alfred Nzo District Municipality or to any other municipality where the bidder's business operations are located are in arrears for more than three months. If you do not pay rates you must submit both an **affidavit stating that you do not pay rates and Proof of residence from the Ward Councillor.**
- **If you do not submit one of the two you will be disqualified.**
- **Please Note that Bidders who are in arrears for ANDM services for a period of more than 3 months will be disqualified. – Submit your water and sanitation statement of ANDM**
- **A Signed lease agreement will be accepted for Bidders that do not own property and not liable for rates.**

- Company profile with traceable references
- All bidders should be registered with CIDB, minimum grading is required (if applicable)
- Joint Venture agreement must be in CIDB JV agreement format otherwise you will be disqualified (if applicable)
- Bidders are required to submit Proposed Project Team, their CV's and qualifications.
- Bids received after the published closing date will not be considered and will be recorded on Late Submission Register


