1. BACKGROUND AND OVERVIEW OF THE PROJECT

1.1 INTRODUCTION

Alfred Nzo District Municipality is hereby inviting suitably qualified and accredited Service Providers to submit their quotations to acquire services of the suitable Service Provider for the **Installation of Network Access Points for Main Office**

1.2 OVERALL AND SPECIFIC OBJECTIVES OF THE PROJECT

1.2.1 Overall objective

The aim of the project is to implement Network Access Points for EmaXesibeni Main office to enable them access to ANDM network using Wi-Fi capable devices.

1.2.2 Specific Objectives

- To install 03 (MR44 WI-FI 6 indoor A.P) cloud managed 802.11ax
- To have a License for 3 years
- Authenticate using existing Active Directory

2. SCOPE & EXTENT OF WORK

Bids are invited from suitably qualified professional service providers to prepare and submit proposals to undertake the implementation of the Network Access Points within the Alfred Nzo District Municipality main office. The following gives a high-level indication of activities to be undertaken;

- The Service Provider (SP) is required to install and configure three (3) wireless Access Points (AP's) for Alfred Nzo District Municipality main office.

- The Service Provider is required to licence all the three wireless Access Points for a period of three (3) years.
- Connection to Access Points (AP's) should not be lost (set up ad-hoc)
- The Service Provider is required to configure all the sixteen wireless Access Points to the Cloud Controller for management purposes.
- The Service Provider (SP) must ensure that Access Points (AP's) are controlled by authentication using existing Active Directory.
- Access Points (AP's) must be Power Over Ethernet (PoE) enabled.
- The Service Provider is required to show the Project Manager configurations of these AP's.

The lowest or any proposal will not necessarily be accepted and Alfred Nzo District Municipality reserves the right to accept or not to accept any proposal either in whole or in part. And any assistance in completing partly or full the proposal from ANDM Official or Councillor will result in disqualification of bid.

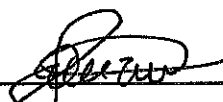
